

ESG Clause for Procurement Contracts

1. Purpose

The purpose of this clause is to ensure that all procurement activities conducted by FLEXTECH SRL adhere to high standards of Environmental, Social, and Governance (ESG) compliance. This clause sets forth the requirements and expectations for suppliers regarding ESG practices.
